** A double asterik "*" denotes that the state or territory reported cell counts, not bed counts. NR indicates that the grantee did Not Report (NR) bed or cell count numbers.

*** The term *purchased* indicates that grant funds were used to purchase, and not construct, the facility. The term *design plans* indicates that grant funds were used to pay for the facility design. The term *construction* indicates that grant funds were used to build a new facility. The term *expansion* indicates that grant funds were used to expand (add bed or call space) to a previously existing facility. The term *renovation* indicates that grant funds were used to construct non-bed or non-cell space (e.g., kitchen, exercise room, etc.). The term *security upgrades* indicates that grant funds were used to provide security upgrades in or around the facility (e.g. perimeter fences, cameras, etc.). The term *leased space* indicates that grant funds were used to lease or contract bed space.
