# American Recovery and Reinvestment Act Correctional Systems and Correctional Alternatives on Tribal Lands

## **Program Performance Report** (April 2011–March 2012)

The following **Program Performance Report (PPR)** examines key findings of the American and Recovery and Reinvestment Act (ARRA) Correctional Systems and Correctional Alternatives on Tribal Lands (CSCATL; formerly Correctional Facilities on Tribal Lands [CFTL]) program from April 2011 through March 2012. To date, 19 Federal awards are classified as "open" and 1 as "closed" in the Grants Management System (GMS). All data analyzed in this PPR are self-reported by individual grantee organizations.

The key objectives of the ARRA CSCATL program are to build and renovate needed tribal justice system facilities and to create and retain jobs while promoting transparency in how federally awarded funds are spent. The program provides funding to help 20 tribes "in cost-effective construction and renovation of correctional facilities associated with the incarceration and rehabilitation of juvenile and adult offenders subject to tribal jurisdiction" and "to explore community-based alternatives to help prevent and control jail overcrowding due to alcohol and other substance abuse convictions." This program is administered by the Bureau of Justice Assistance (BJA) in coordination with the Bureau of Indian Affairs (BIA) and the Office of Juvenile Justice and Delinquency Prevention (OJJDP).

Table 1 shows the number of grantees conducting construction and renovation projects during the reporting periods examined in this PPR. In total, 20 awards were made to tribal entities. During the last 3 quarters examined, 13 grantees that reported into the Performance Measurement Tool (PMT) are conducting construction projects, and 4 grantees are conducting renovation projects. During the last three quarters examined, 15% (3) of the grantees either were *not operational*, *not active*, or *did not report* in the PMT.

### **Key Findings and/or Observations**

- On average, 55 collaborative partnerships have been reportedly developed each quarter. Almost 40% are in probation and parole services (19%) and in law enforcement (19%).
- Most grantees (77%) are completing middle-stage construction milestones.
- Almost half (6 of 13, or 46%) of the grantees are nearing completion of their late-stage construction milestones.
- Two (of 13) grantees have new buildings substantially complete.


<sup>\*</sup>Milestone measures were selected based on a variety of criteria, including the amount of data available for each measure and whether most grantees had data to report for a particular measure. For example, most grantees were not ready to report a status of "Complete" on measures such as "Commence Occupancy and Initial Operations." Instead, other measures were chosen that more accurately reflected the status of most grantees. Most grantees are in the middle stages of construction-site work, and a few are moving toward late-stage construction milestones. Therefore, indicators were chosen that are more applicable to grantees in middle-stage construction, such as construction being 50% complete. As more grantees progress through the construction stage and near completion, these measures will be adjusted to reflect the progress of most grantees.

## **Graphs of Key Measures**

#### Collaborative Partnerships Established

This graph shows the number of collaborative partnerships developed by quarter. The predominant partnerships included community corrections/probation and parole services (19 percent) and law enforcement (19 percent).

On average, 55 collaborative partnerships were developed in each quarter.





#### **Construction Milestones**

Thirteen (13) active grantees reported in the PMT during the last three quarters ending March 31, 2012. All 13 grantees answered questions about the key measures. Eleven (11) active grantees reported during the April–June 2011 quarter. Grantees doing construction projects are asked to complete up to 33 *milestones*, which act as a checklist that is generally completed in sequential order. Not all grantees will complete all milestones, but most grantees that complete construction projects will also complete most of the milestones. The following looks as some of the key milestones to gauge the progress grantees are making with their construction projects.

#### Construction Milestones Accomplished (1–2 Months)

This graph shows the general progress that grantees are making with early-stage construction. By the January–March 2012 quarter, all 13 grantees (100%) had appointed a project manager. Twelve grantees (92%) have established a total project budget, selected and retained an architecture and engineering firm, and formed a transition team.






#### Construction Milestones Accomplished (2–8 Months)

This graph shows the general progress grantees are making with the middle stages of construction. The number of grantees submitting 99% of design documents to the Bureau of Indian Affairs, Office of Facilities Management and Construction and Division of Safety and Risk Management (BIA OFMC and DSRM) for review increased from 6 (55%) in April–June 2011 to 10 (77%) in January–March 2012. As of the last quarter examined, 10 grantees (77%) have submitted their final construction documents, up from 5 (45%) in the first quarter.

#### Construction Milestones Accomplished (8–32 Months)

This graph shows the general progress grantees are making with the final stages of the construction process.

Six (46%) grantees have commenced construction as of the January–March 2012 quarter, and all but one of those has completed at least 50% of construction. One grantee did change their response for the commence construction question from "complete" to "not yet complete" during the July–September 2011 quarter. Two grantees (15%) have construction substantially completed.




#### **Renovation Milestones**


Four (4) active grantees reported in the PMT over the four quarters. One grantee reported in the PMT for all four quarters, two reported for three, and one reported for one. Grantees doing renovation projects are asked to complete up to 27 *milestones*, which act as a checklist that is generally completed in sequential order. Not all grantees will complete all milestones, but most grantees that complete renovation projects will also complete most of the milestones. The following graphs look as some of the key milestones to gauge the progress grantees are making with their renovation projects.

#### Renovation Milestones Accomplished (1–2 Months)

This graph shows the general progress grantees are making with the initial stages of the renovation process. Grantees are at various stages of their renovation projects. All grantees initially established a total project budget, and at least one is making revisions. At least one grantee has reached the 1–2 month key measure during each of the last four quarters.

#### Renovation Milestones Accomplished (2–8 Months)


This graph shows the general progress grantees are making with the middle stages of the renovation process.

In each of the four quarters, at least one grantee reached one of the key milestones.

#### Renovation Milestones Accomplished (8–32 Months)

This graph shows the general progress grantees are making with the final stages of the renovation process.

Half of the grantees awarded contracts to a selected renovation/construction company during the April–June 2011 quarter, and 2 grantees reported their renovations were substantially complete. In the most recent quarter, no additional grantees commenced renovation or reported their renovations were 50% or more complete.



# **Trend Analysis and Interpretation**

This section points out patterns and trends among performance measures across all grantees reporting.

- The PMT completion rate for this program was very high (95%) for all quarters examined. All but one of the active grantees reported for all four quarters examined. One grantee did not report in the PMT for the last three quarters examined. During the quarter in which this lone grantee did report, they were nearing completion of their renovation project.
- Two of the 20 ARRA CSCATL grantees (10%) substantially completed construction and renovation projects.
- Two of the four grantees conducting renovation projects are still in the early stages of construction.
