


## Building Neighborhood Capacity Program (BNCP)

The *Building Neighborhood Capacity Program* (BNCP) helps low-income neighborhoods build the infrastructure and access the resources needed to ensure residents and families experience better results around education, employment, safety, housing and other key areas. Established in 2011, as part of the federal [Neighborhood Revitalization Initiative](#) (NRI), BNCP continues to grow while catalyzing community-driven change in neighborhoods that have historically faced barriers to revitalization.

While situations vary locally, persistently distressed neighborhoods often have a history of low or poorly targeted investments from the public and private sectors, may not be well-connected with institutions such as universities and hospitals, are far from economic vitality, and may have experienced racial or class segregation that severely limits opportunities. In addition, these neighborhoods often face several challenges, including high rates of crime, limited access to affordable housing, and low educational attainment. As these issues are interrelated, they must be addressed holistically. BNCP partners have used nearly 30 years of work in communities, as well as research and literature from the field, to develop a framework of capacities that are essential to creating successful and sustainable neighborhood transformation. **The goal of BNCP is to help neighborhoods develop this community capacity – the knowledge, skills, relationships, interactions and organizational resources - that enables residents, civic leaders, the public and private sectors and local organizations to create comprehensive neighborhood revitalization plans.**

## The BNCP Neighborhoods Work To...

### ***Develop a Community Process to Achieve Results***

Each BNCP neighborhood is developing an inclusive process that includes residents and stakeholders and provides the community with a framework for moving from talk to action in support of achieving results for all residents, children and families.

### ***Build Community Capacity***

Each BNCP neighborhood identifies the capacities essential to achieving results and improving outcomes. While all of the neighborhoods are committed to building and deepening resident leadership, some specifically choose to increase their ability to use data to make informed decisions while others focus on building accountable partnerships with neighborhood organizations and other invested stakeholders.

### ***Design and Implement a “Learn While Doing” Project***

In collaboration with residents and community partners, each BNCP neighborhood designs and implements a project to address one of the neighborhood’s most pressing challenges while also helping to build new and strengthen existing community capacity.

### ***Develop a Results-Driven Revitalization Plan***

At the end of BNCP, neighborhoods will have developed a revitalization plan outlining the neighborhood’s vision and plan for continuing to achieve results.
