# Health Care: A Public Safety Opportunity

Across the country, criminal justice and health practitioners, administrators, and policymakers are implementing innovations aimed at fulfilling the promise that health reform holds for justice-involved populations: better access to services that will result in safer and healthier communities. The hope is that newly available coverage of primary care and addiction and mental health treatments can translate into decreased crime, fewer jail and prison admissions, and reduced recidivism among justice-involved individuals who have never before had this level of access to services. To promote these outcomes, the Bureau of Justice Assistance is partnering with the Legal Action Center (LAC) and associates, Advocates for Human Potential and TASC, Illinois, to offer technical assistance to justice professionals. As part of this work, LAC and its partners are launching the Justice & Health Innovation Bulletin, a monthly newsletter that will keep readers informed about resources and opportunities to increase public safety through improved access to health care. The Bulletin fosters an exchange of information between professionals, highlights federal health and criminal justice policy developments, and responds to the technical assistance needs of practitioners with the program and policy expertise a shifting health care landscape requires.

## Spokane Municipal Community Court

Each month, we will feature a justice program that is taking advantage of health reform to improve public safety and justice outcomes. This month we profile the Spokane Municipal Community Court in Washington State.

Spokane Municipal Community Court is a great example of a front-end effort to leverage behavioral health intervention and treatment into crime prevention for affected communities. Spokane Community Court defendants get an opportunity to resolve their misdemeanor criminal charges without jail time or criminal conviction, and receive help with health benefit enrollment and connections to covered services. Indicators suggest these measures can improve the health of vulnerable populations and prevent a cycle of repeat court appearances and jail stays. Communities with high unmet needs for addiction and mental health services are often plagued by a steady stream of individuals passing through a revolving door in and out of custody. It all started when Municipal Court leaders, police, public defenders and prosecutors began talking with local hospitals about the needs of homeless individuals living downtown. Full text

#### **HRSA** - Find a Center

Enter any U.S. address to find Federally Qualified Health Centers (FQHC) within 10 miles.

FQHCs all over the U.S. assist with benefit enrollment, accept Medicaid and other health coverage, and can help link people with mental health and substance use disorders to services.

#### National Academy For State Health Policy - PCMH Initiative

A U.S. map and state listing of patient-centered medical home and health home plans.

Health Homes allow patients with chronic behavioral health and other health conditions to receive better coordinated care.

#### **CMS – From Coverage to Care**

Educational materials; infographics; series of short videos that explain how to use benefits.

SAMHSA Convenes Public Listening Session on Rules Governing Confidentiality of alcohol and drug records: SAMHSA held a public listening session on Wednesday, June 11, 2014, to solicit information concerning the Confidentiality of Alcohol and Drug Abuse Patient Records Regulations, 42 CFR Part 2. **National Drug Control Strategy Released by ONDCP:** On July 9<sup>th</sup>, the White House Office of National Drug Control Policy (ONDCP) released its annual National Drug Control Strategy. The strategy serves as a blueprint for reducing drug use and its consequences.

Informational Bulletin on Medication Assisted Treatment for Substance Use Disorders issued by CMS and Other Federal Health Officials: On July 11th, Cindy Mann, Director of CMS's Center for Medicaid and CHIP Services, and the Directors of the CDC, SAMHSA, NIDA, and NIAAA, jointly issued an Informational Bulletin with guidance on medication assisted treatment for SUD. It identifies approved medications and successful treatment strategies that are used in combination, advises state Medicaid agencies on managing medication-assisted treatment, and identifies related resources.

**Technical Assistance Program with Substance Use Disorder Focus** launched by CMS: On July 14<sup>th</sup>, the Centers for Medicare & Medicaid Services (CMS) announced the Medicaid Innovation Accelerator Program. This new CMS technical assistance project will have a specific focus on reducing substance use disorders by supporting delivery system innovations. CMS will provide technical assistance to states to accelerate the development and testing of SUD service delivery innovations through the program.

<u>Final Report on Behavioral Health Data Exchange Project</u> released by ONC: In June, the Office of National Coordinator for Health Information Technology (ONC) released a final report for their State Health Policy Consortium Project on Behavioral Health Data Exchange.

Final Mental Health Parity and Addiction Equity Act (MHPAEA) Rule becomes effective for certain commercial plans: On July 1<sup>st</sup>, final regulations to implement the federal Mental Health Parity and Addiction Equity Act (MHPAEA) became effective for certain plans. MHPAEA requires certain private and public health plans to cover mental health and substance use disorder benefits in no more restrictive a way than they cover other medical and surgical benefits.
