EVALUATION CONSULTING PROVIDED BY THE BJA CENTER FOR PROGRAM EVALUATION

During the 2006 BJA Regional Conference series, BJA Center for Program Evaluation staff provided on-site evaluation consulting services. Approximately 20 consulting sessions were held across the four regional conferences. This conference series represented the first time the BJA Center for Program Evaluation provided on-site evaluation consulting. Conference attendees who had specific questions about evaluation or performance measurement or who wanted to learn more about the BJA Center for Program Evaluation Web Site signed up at the cyber clinic table for 30 minute one-on-one consulting sessions. Staff answered questions relating to developing evaluation protocols for site visits, performance measures, program evaluation, incorporating evaluation in RFPs, implementing and sustaining community-based programs, as well as general questions about the web site and technical assistance.
